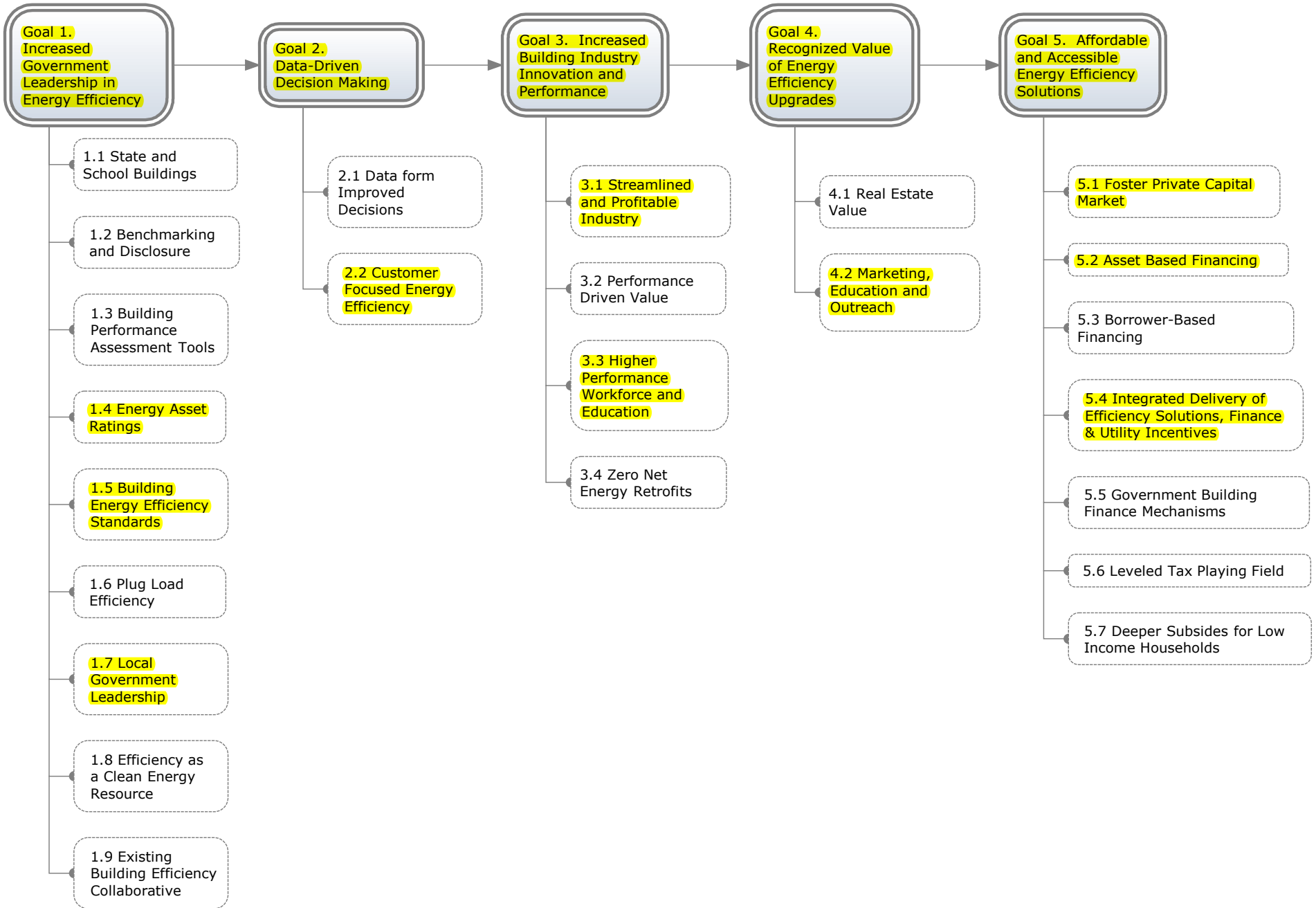
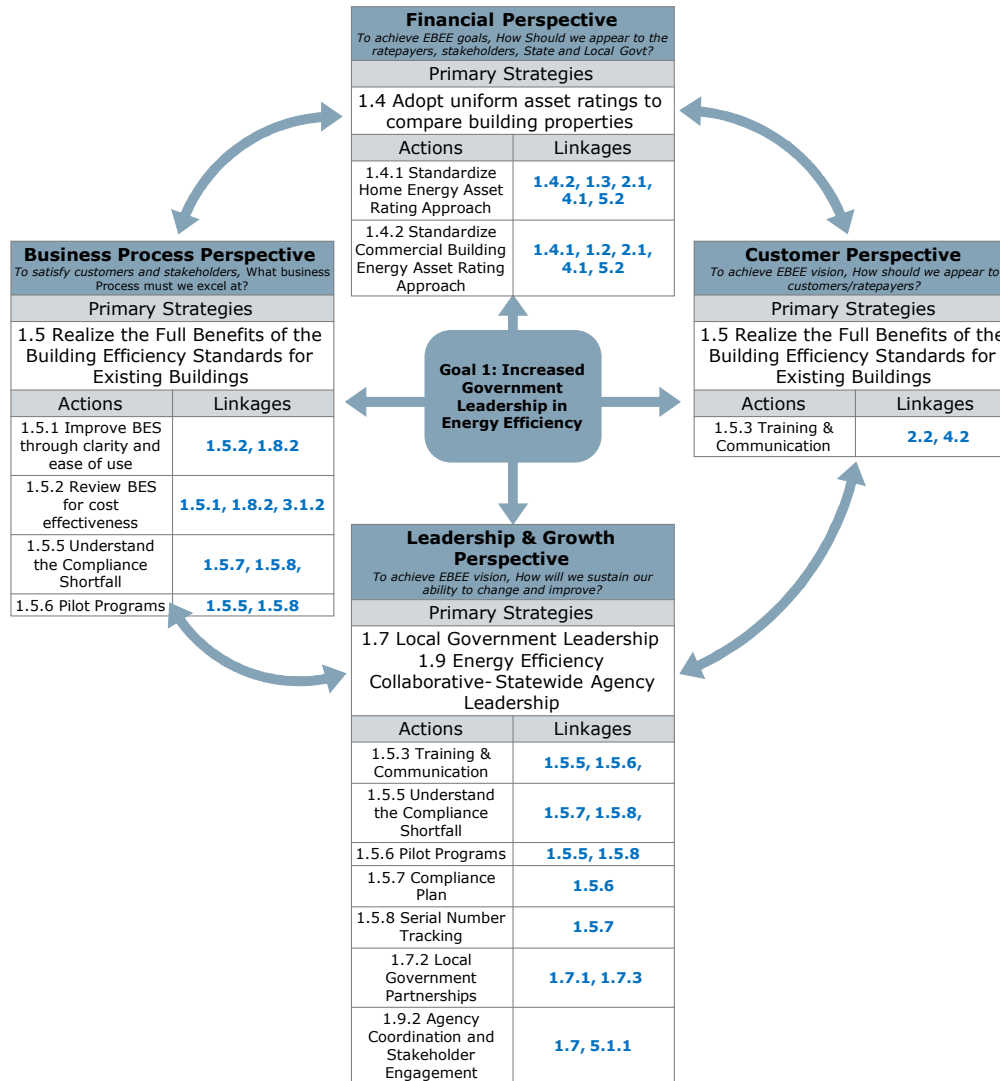


AB 758 Existing Buildings Energy Efficiency Action Plan





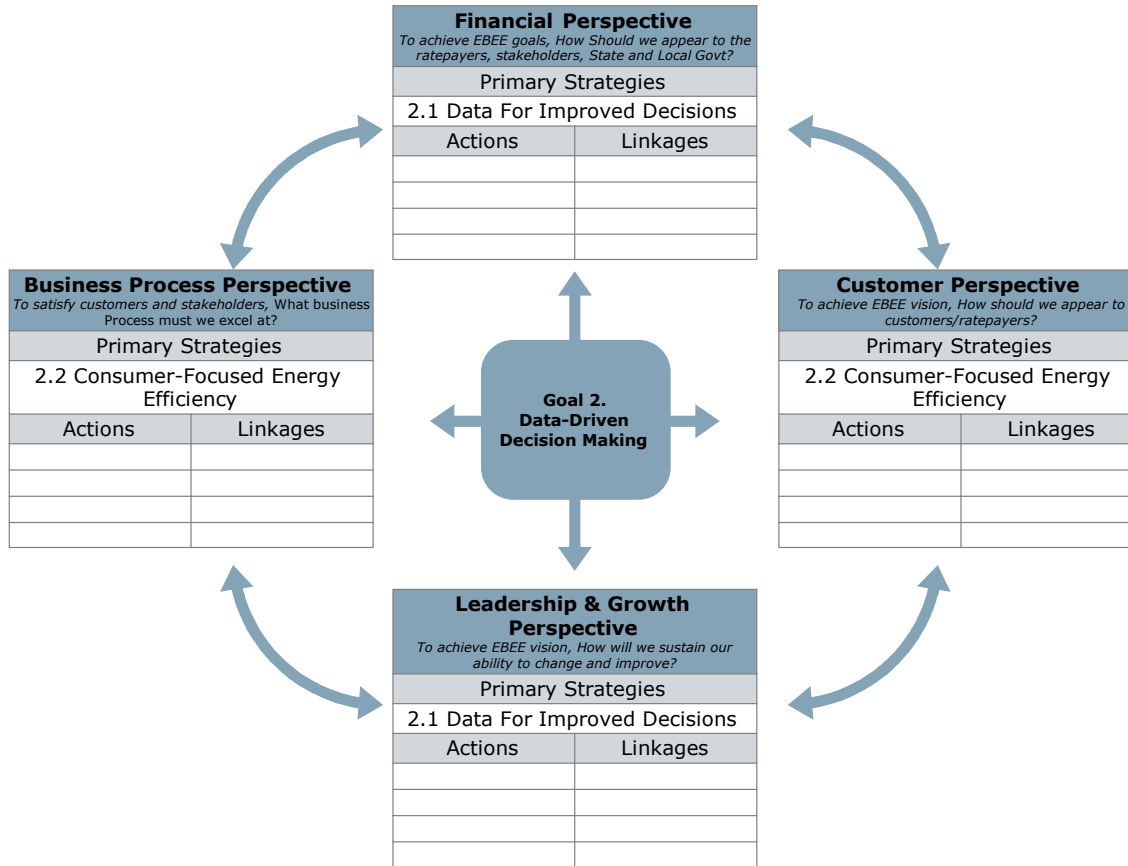
