Approve Minutes of Previous Meeting

There was not a quorum to approve the April 21, 2017, CQI Meeting minutes; an email vote request for approval has been sent to members.

CI Data Spec Working Group Update – Pete Jacobs (BMI)

- Goal #3: Data Specs Complete and approve a specification to measure and score the performance of installed commercial maintenance and residential installation HVAC systems.
 - o The Working Group is pretty close to wrapping up data specs activities:
 - CQI data specs approved by EC in January 2017;
 - Delivered the RQI data specs in April 2017 to the RQI Committee;
 - QM Specs: WG members are still reviewing the draft QM specs. Pete Jacobs (BMI) will
 incorporate feedback and send to the CQM Committee for their consideration in early July.
- Goal #4: Determine the calculation methods for "developing a standardized, repeatable performance-based method for system evaluation.
 - Pete Jacobs (BMI) is working on the HVAC system's calculation methods in conjunction with the ASHRAE SPC 221 Committee.
- Goal #5: Develop simplified test protocols supporting procedures forming a HVAC system performance assessment process that could be effectively utilized by HVAC and EM&V professionals in the field to measure and score the performance of installed HVAC systems.
 - o Pete Jacobs (BMI) noted that work will begin later in the year.

ASHRAE SPC 221 Update – Ben Lipscomb (NCI)

- On track with original schedule to have approval by December 2017. The SPC 221 Committee will review and discuss the final Draft Proposed Standard at the 6/26/17 ASHRAE Summer Meeting in Long Beach.
 - o Close to having public review. Various task groups have been working on finalizing the standard.
 - Scope and title revisions were submitted to ASHRAE. The scope more clearly defines the types of systems that are applicable. It calls out air-sourced HP or air-delivery DX. The title has been shortened.
 - o Current proposed schedule for approval:
 - Final revisions, comments, and edits are due by Monday, July 10, 2017.
 - Final version sent to SPC 221 Committee on by August 17, 2017.
 - Email vote from SPC 221 Committee on August 21, 2017.
 - Distributed for public review in late August.
 - Public review in September and October.
 - Responses to Public Review comments.
 - Final Standard 221 Committee vote in November.
 - Approval by ASHRAE Standards Committee at Winter Meeting; publication to follow.
